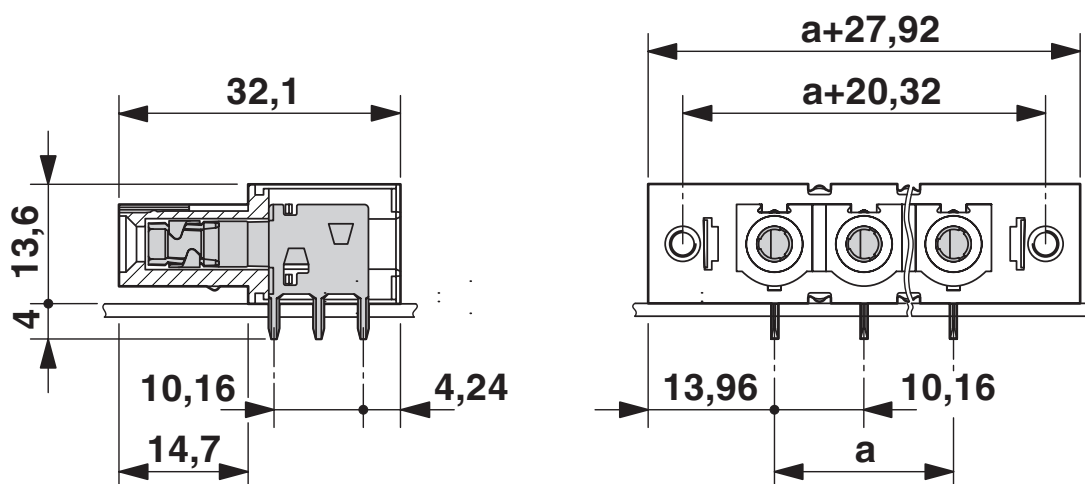

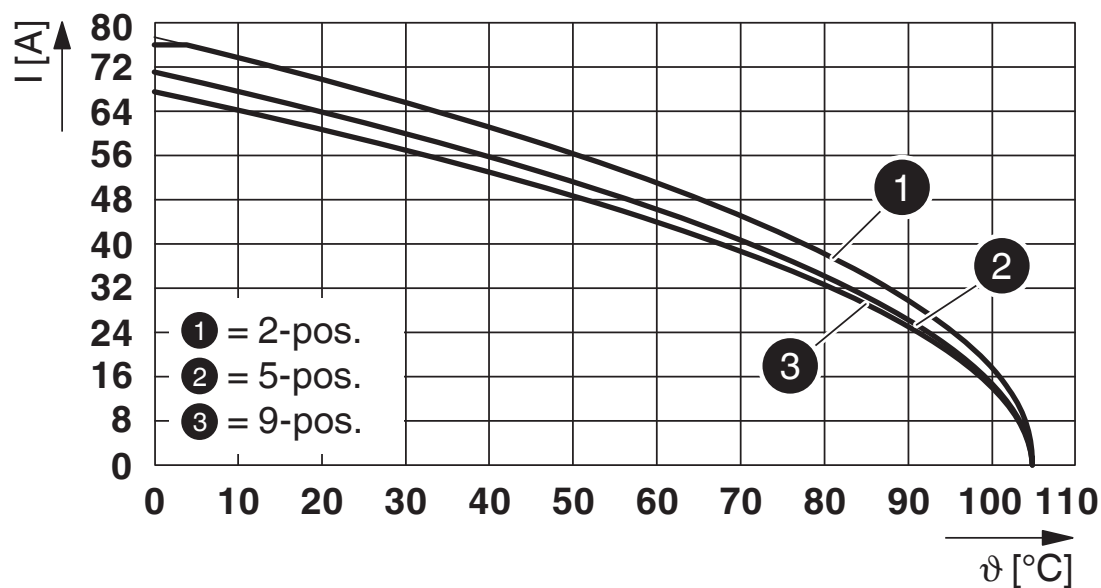

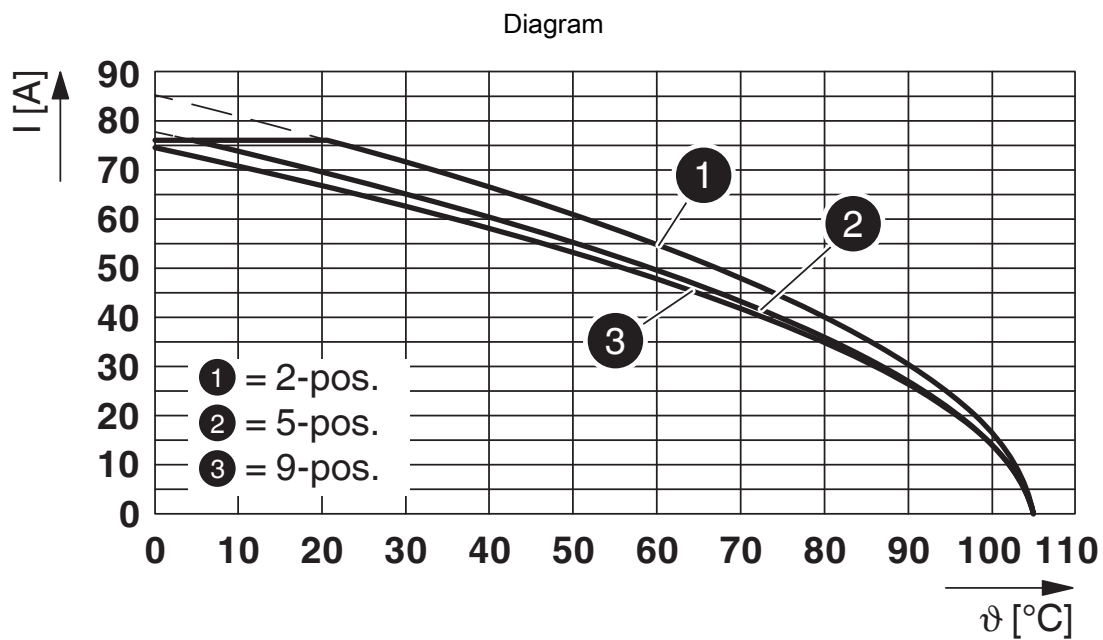


The figure shows the 3-pos. version
