

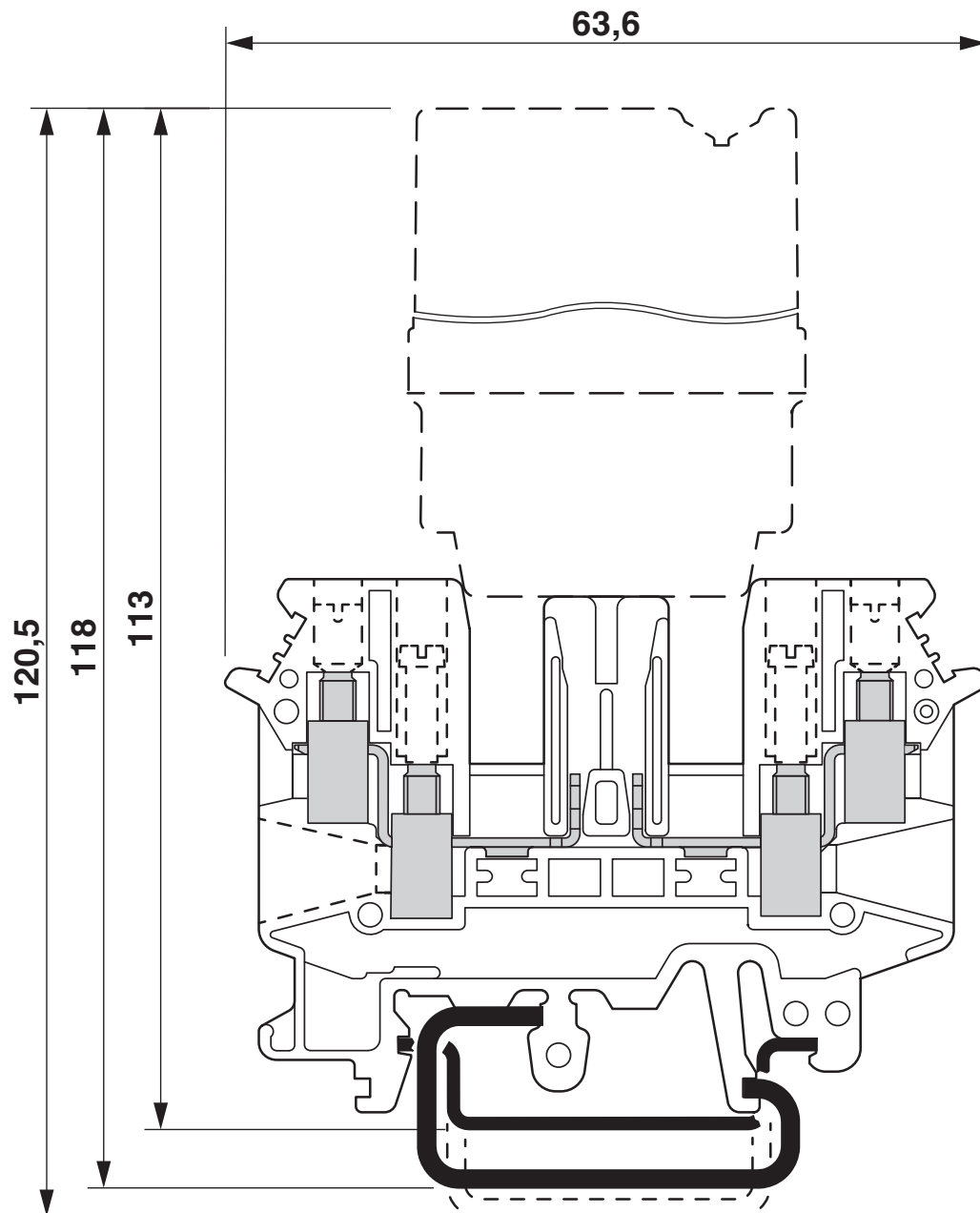

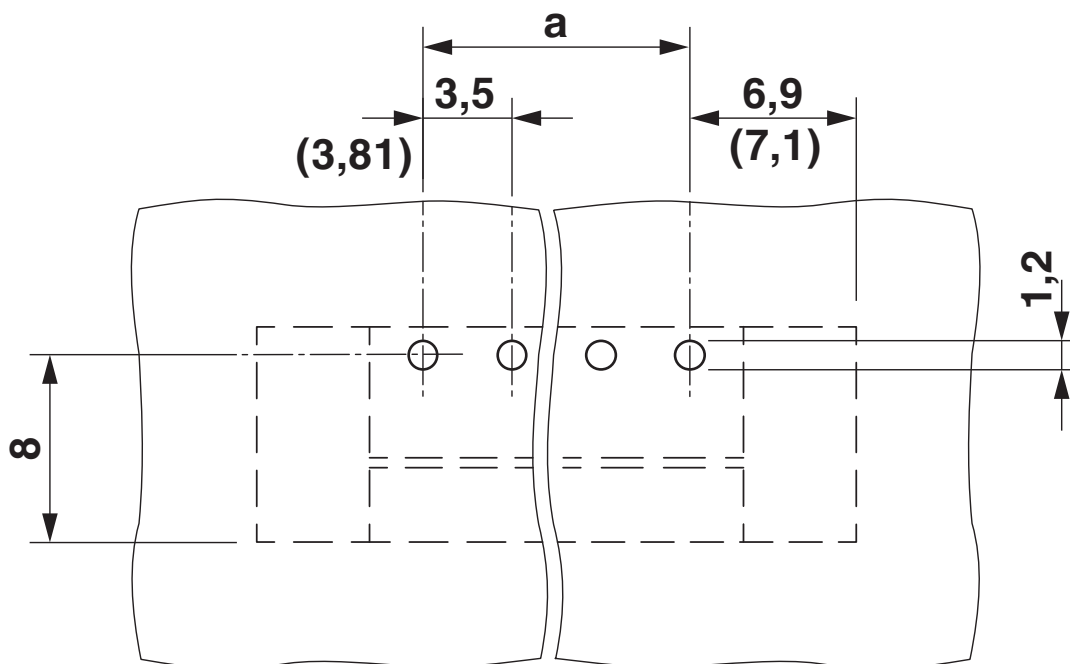

1-3 = fixed bridge, cross connection rail, spacer

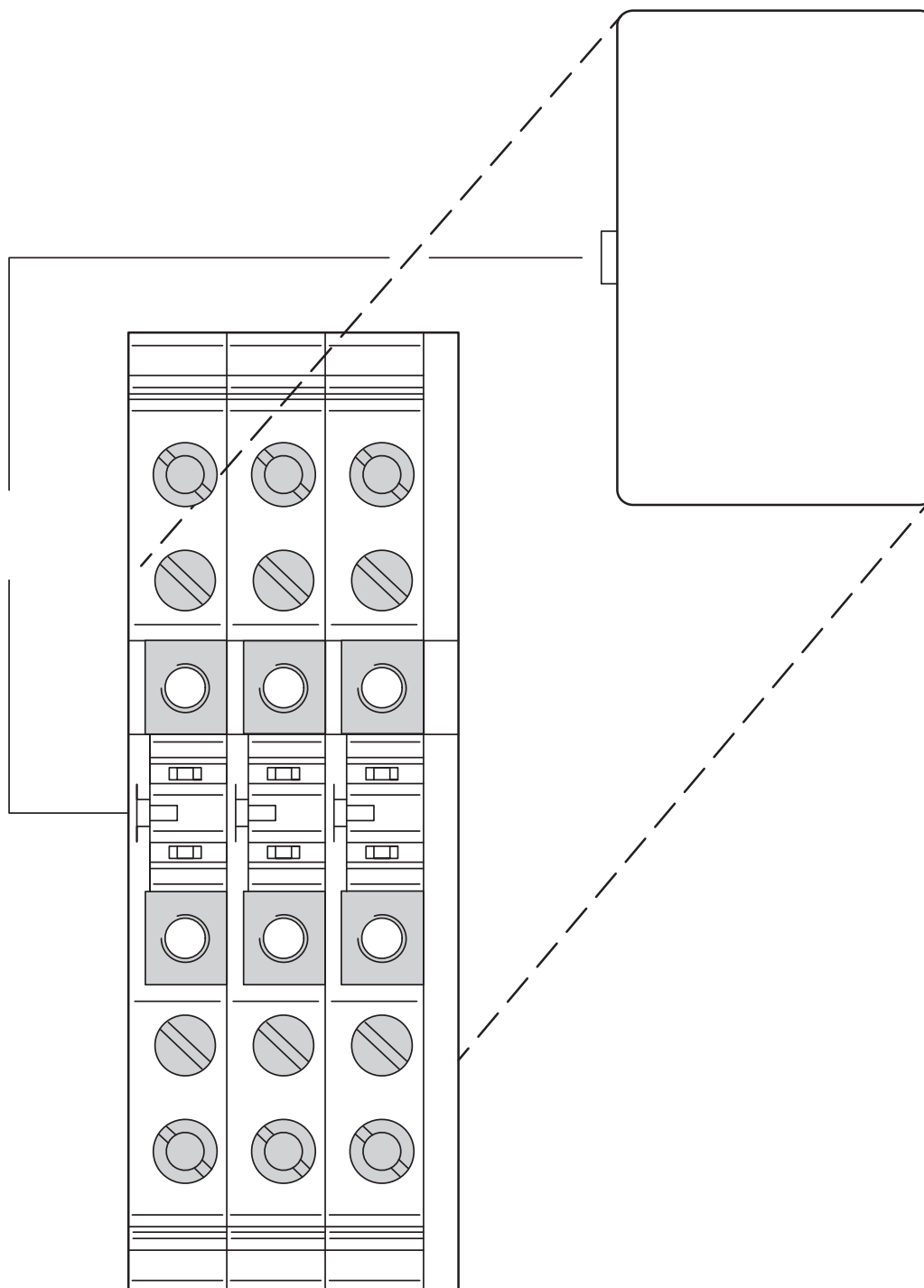
