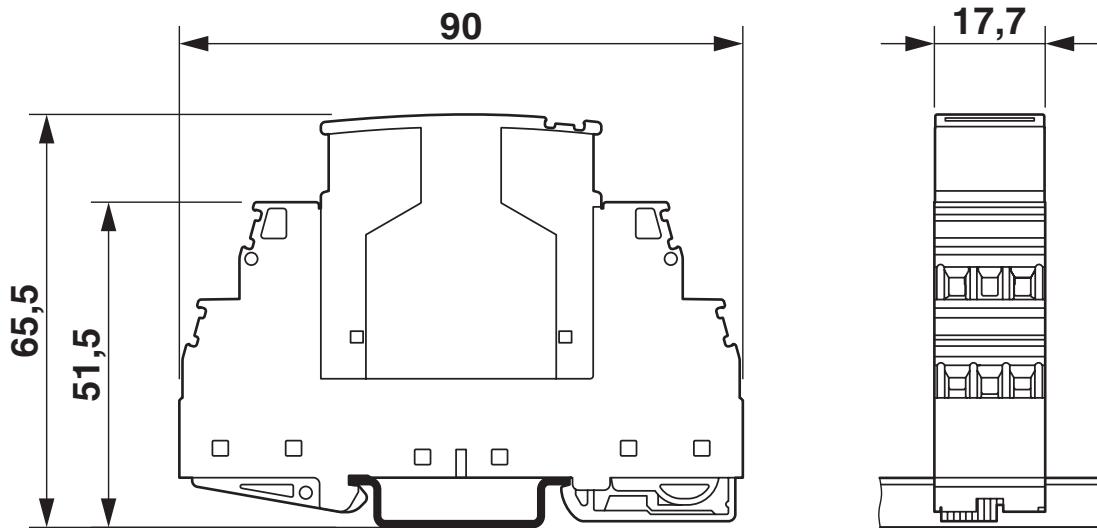

The figure shows the complete module consisting of a base element and connector



Diagram




