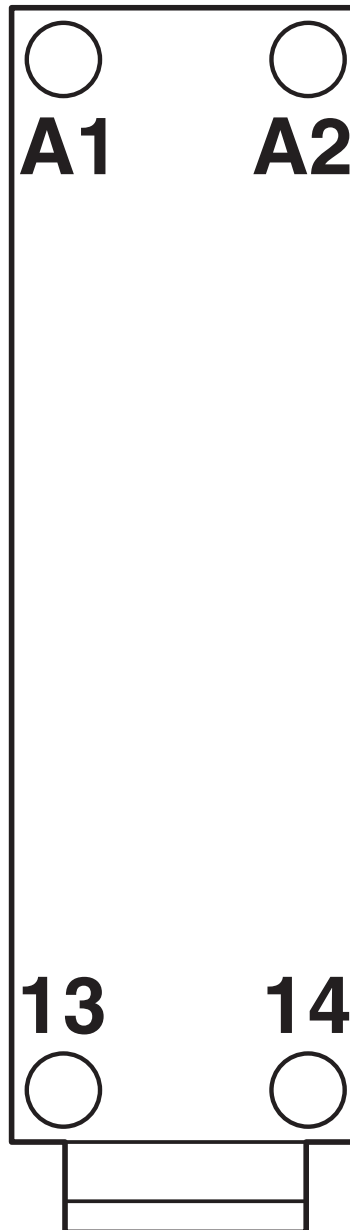

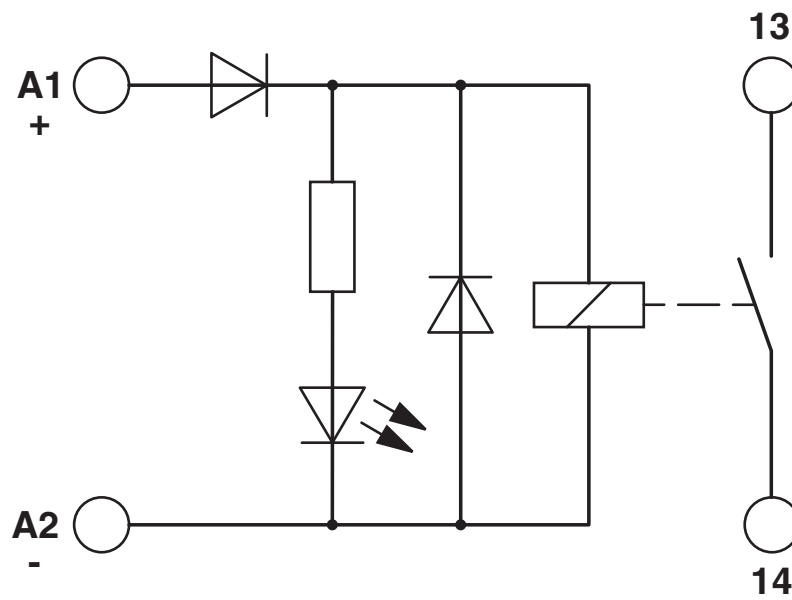

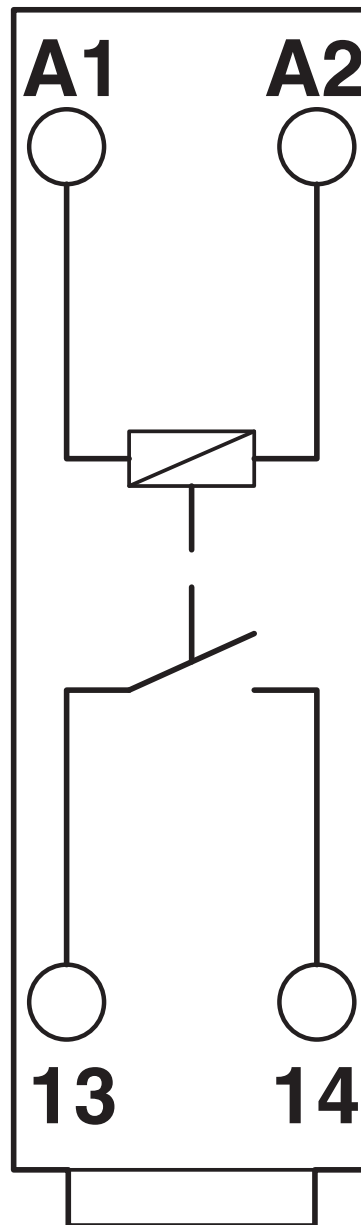
Connection diagram
