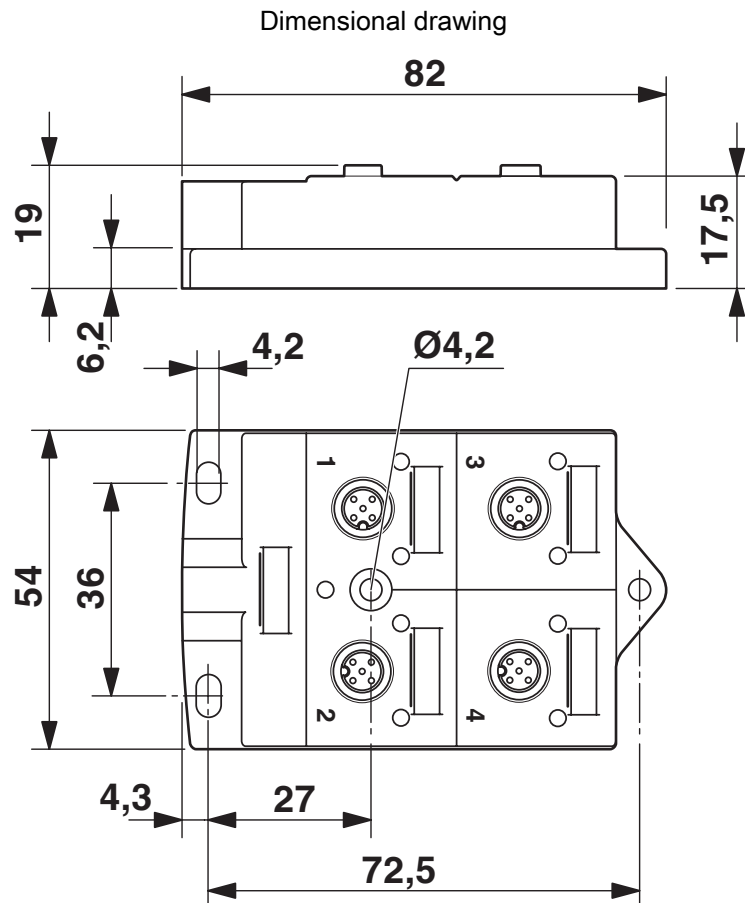

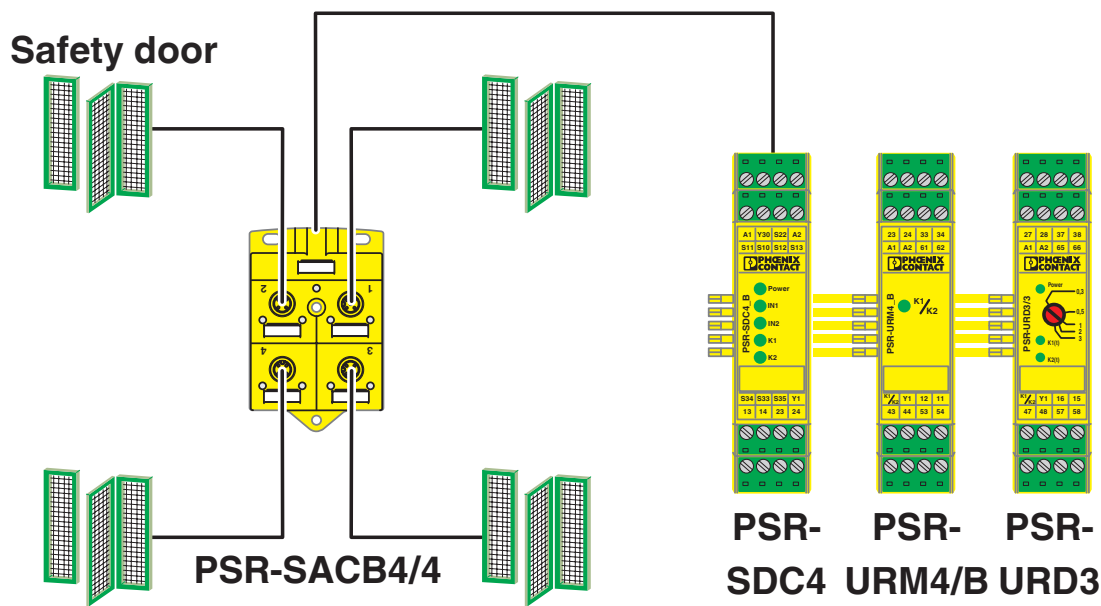

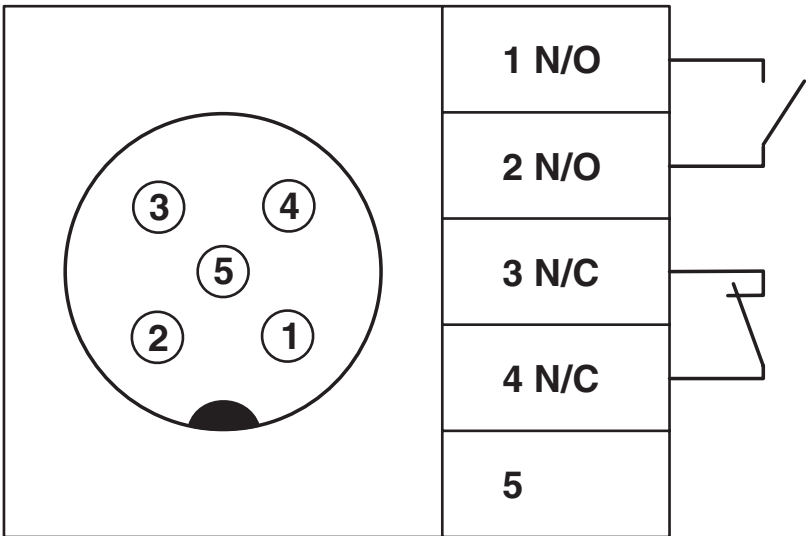

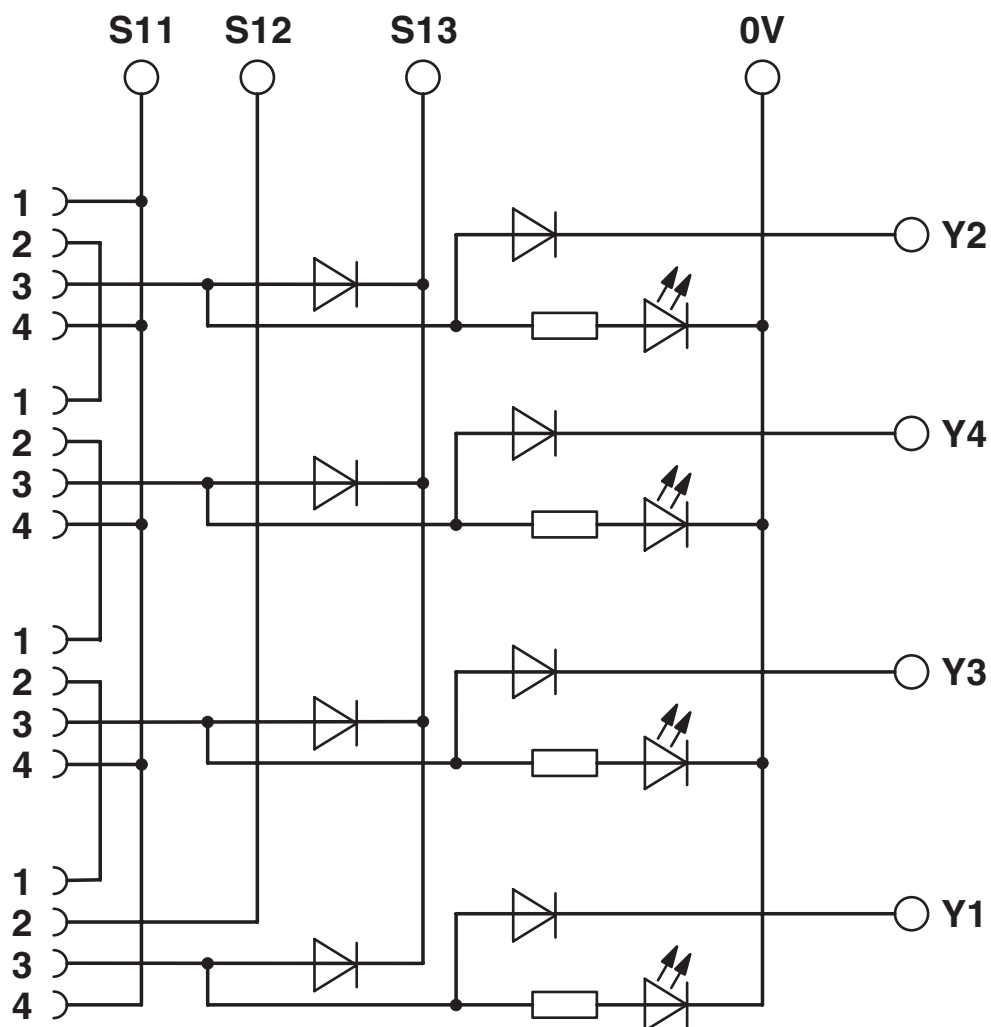
Signals of up to 4 safety door switches can be switched together directly in the field.
