It can operate at temperatures between 0 and 70C. Our transceiver is built to meet or exceed OEM specifications and is guaranteed to be 100% compatible with Hirschmann®. It has been programmed, uniquely serialized, and tested for data-traffic and application to ensure that it will initialize and perform identically. All of our transceivers comply with Multi-Source Agreement (MSA) standards to provide seamless network integration. Additional product features include Digital Optical Monitoring (DOM) support which allows access to real-time operating parameters. This transceiver is Trade Agreements Act (TAA) compliant. 


## Notes:

1. The module signal ground contacts, VeeR and VeeT, should be isolated from the module case.
2. This contact is an open collector/drain output and should be pulled up to the Vcc\_Host with resistor in the range 4.7KΩ to 10KΩ. Pull ups can be connected to one or several power supplies, however the host board design shall ensure that no module contact has voltage exceeding module VccT/R +0.5.V.
3. Tx\_Disable is an input contact with a 4.7KΩ to 10KΩ pull-up resistor to VccT inside module.
4. Mod\_ABS is connected to VeeT or VeeR in the SFP+ module. The host may pull the contact up to Vcc\_Host with a resistor in the range from 4.7KΩ to 10KΩ. Mod\_ABS is asserted “High” when the SFP+ module is physically absent from a host slot.
5. Internally pulled down per SFF-8431




Pin-out of connector Block on Host board
