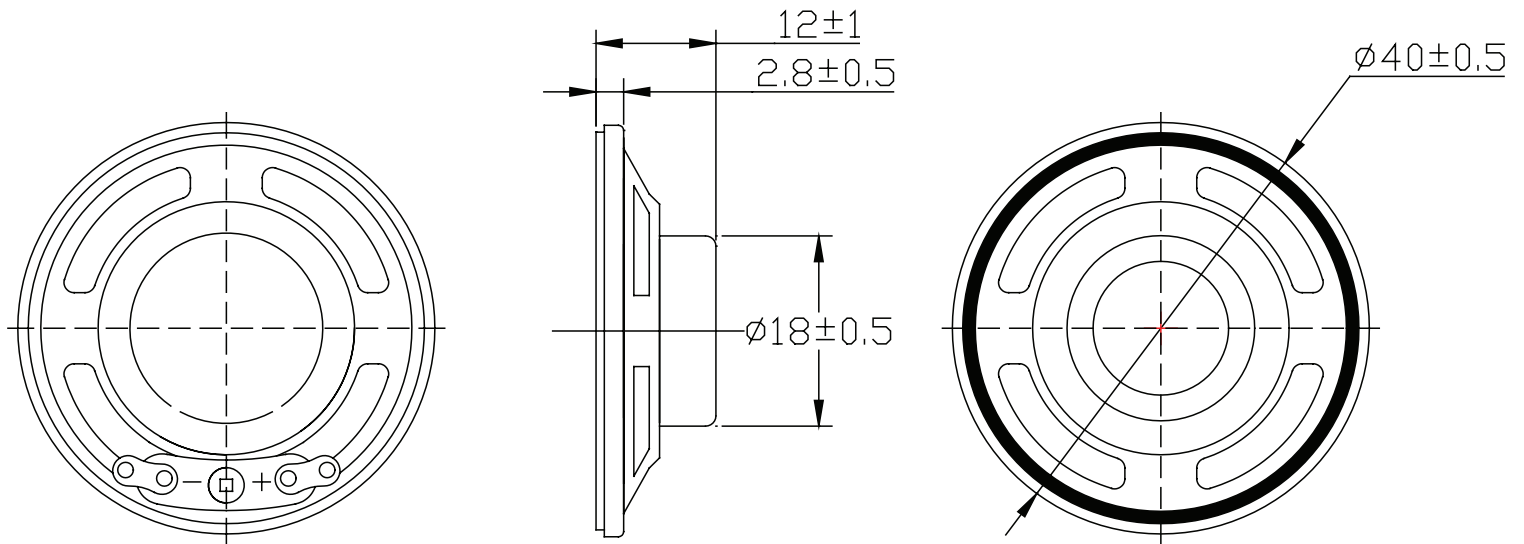

MECHANICAL DRAWING (SOLDER EYELET)

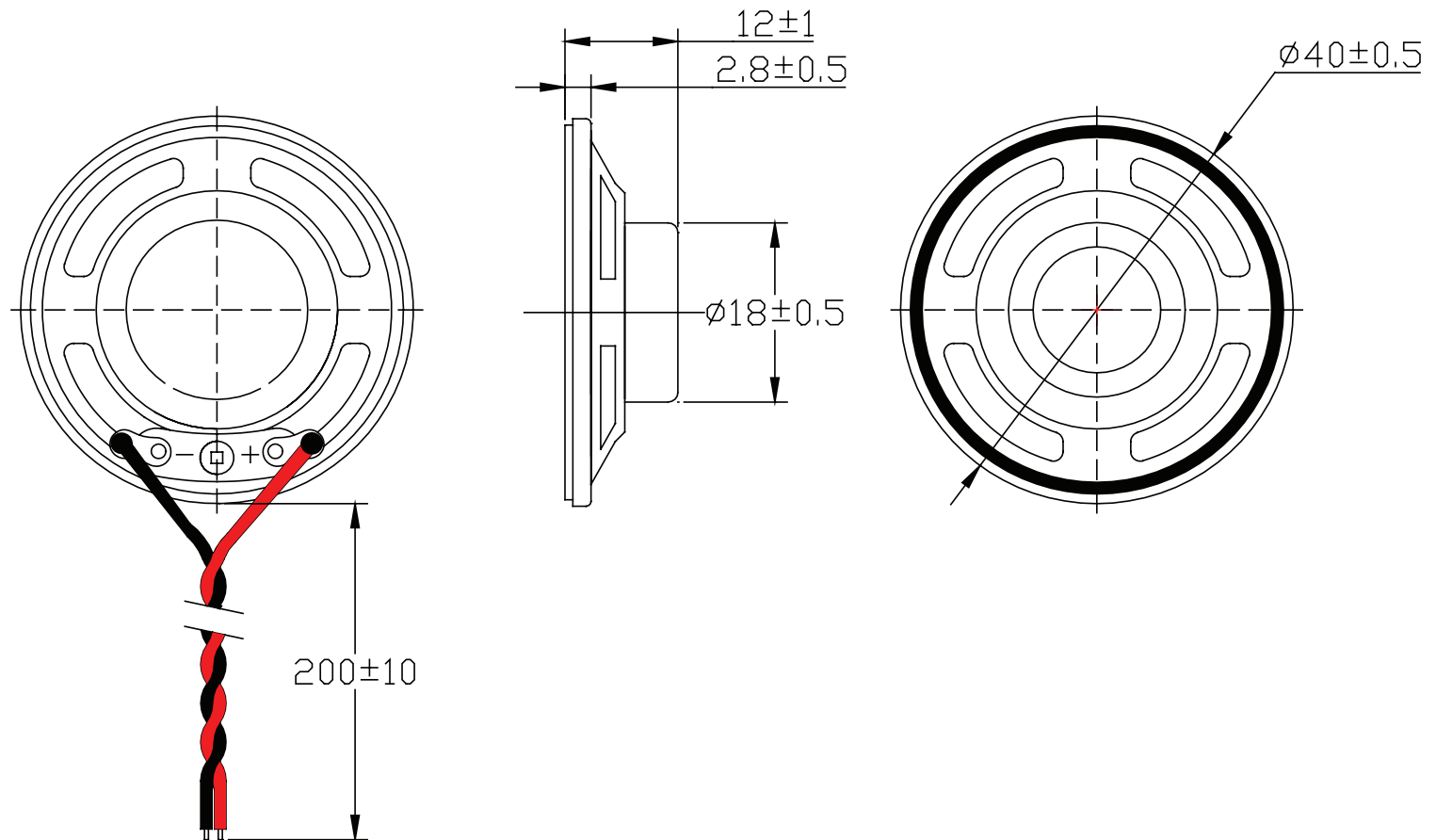

MECHANICAL DRAWING (WIRE LEADS)

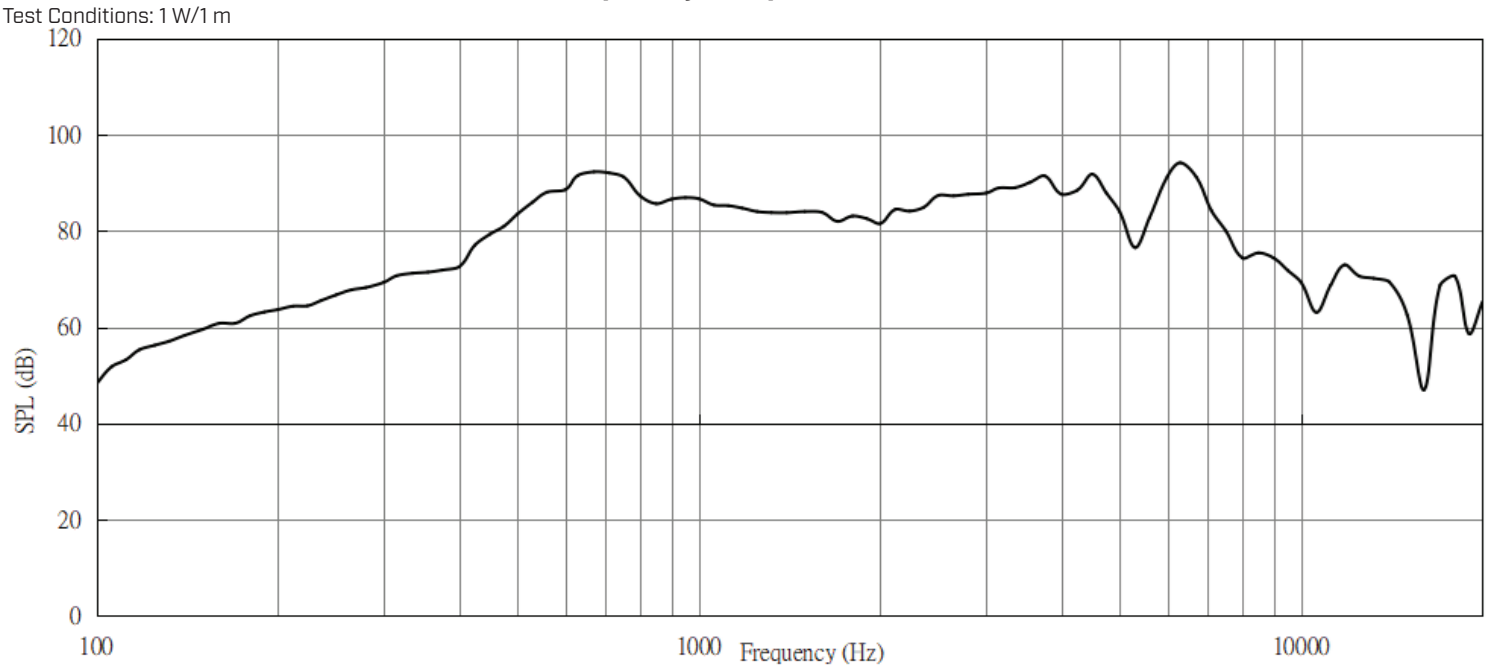

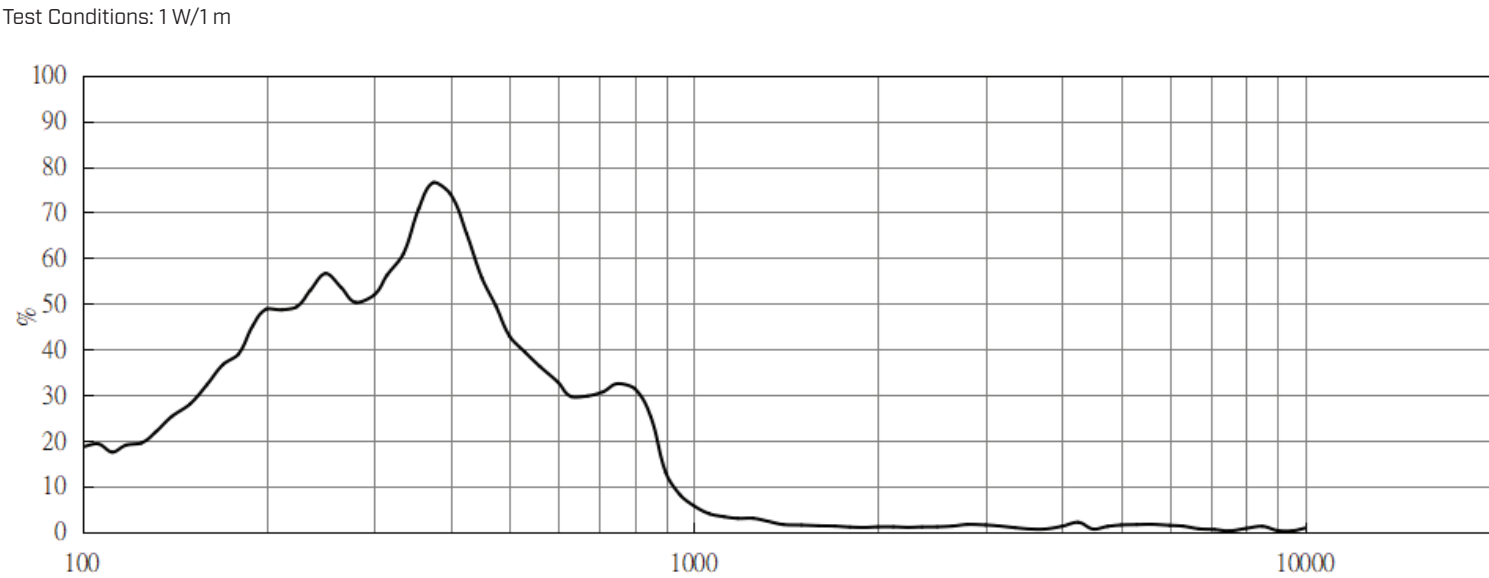


RESPONSE CURVES
