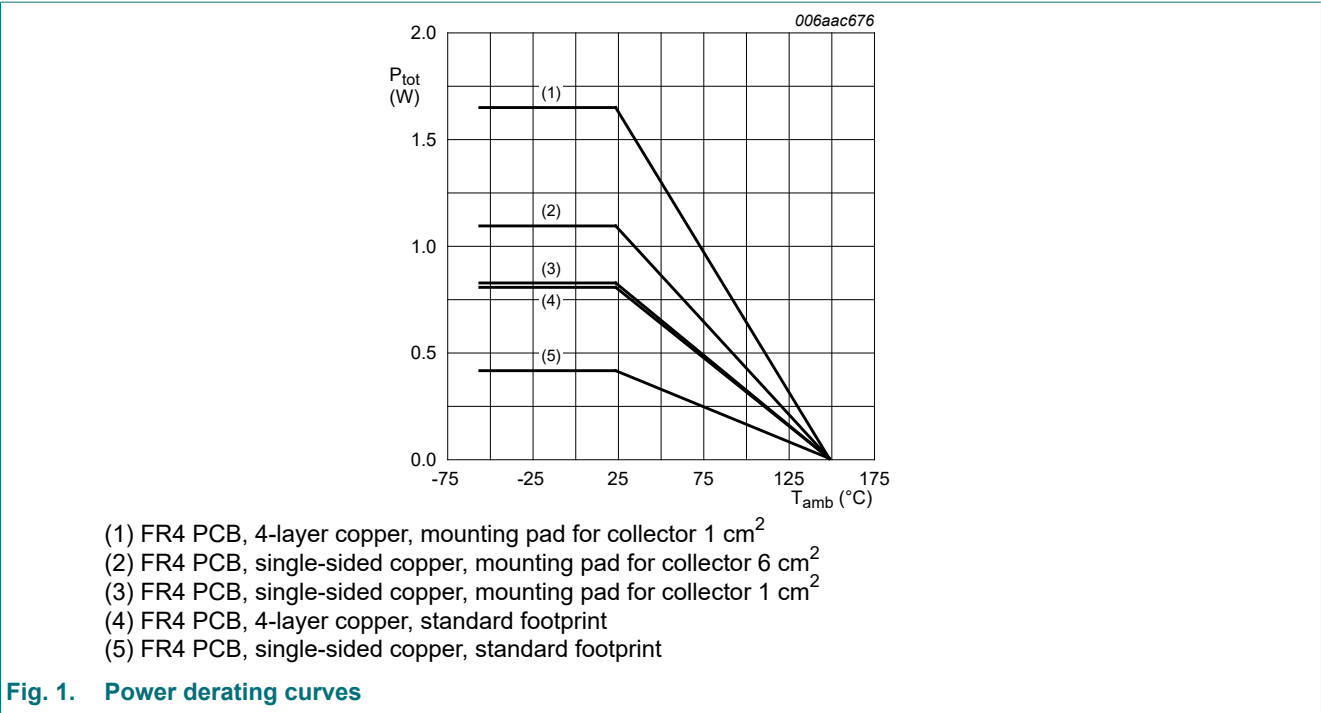

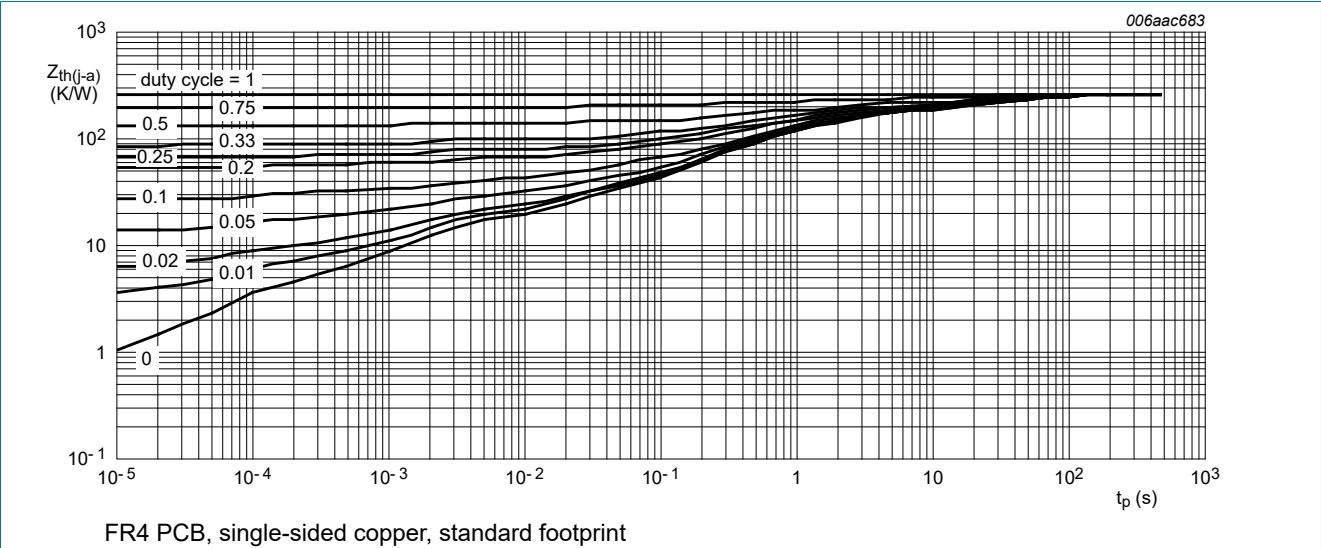


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

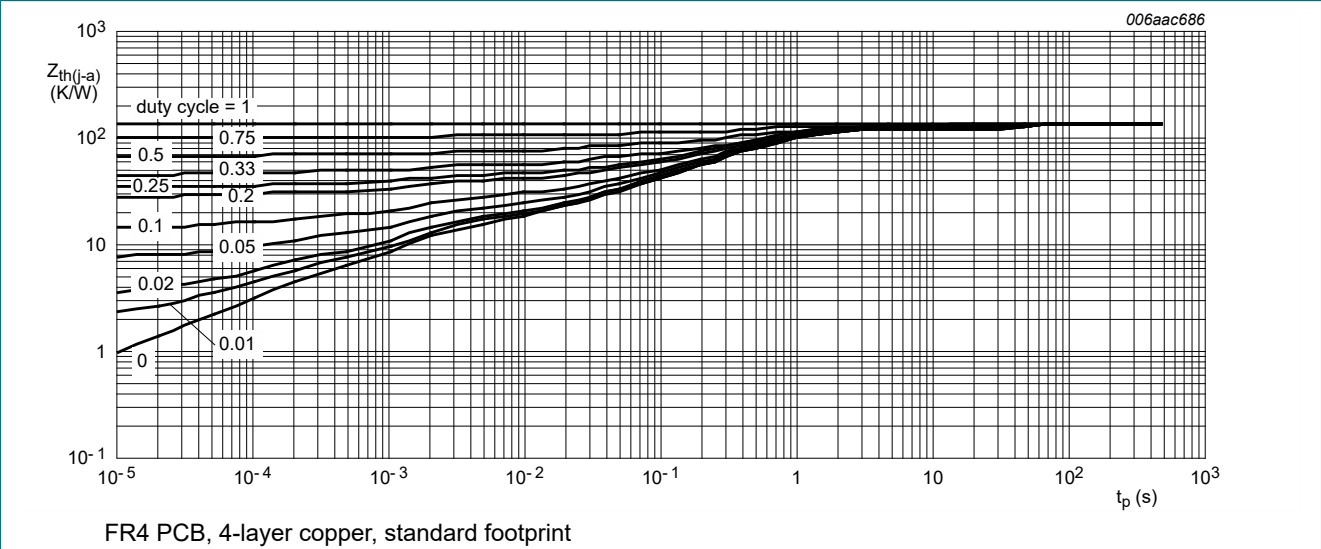
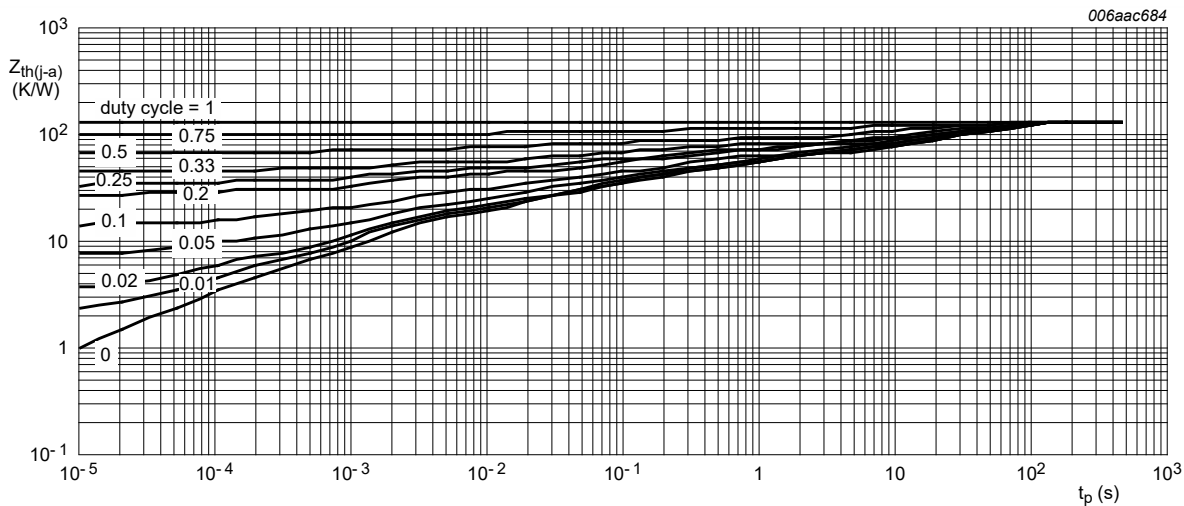
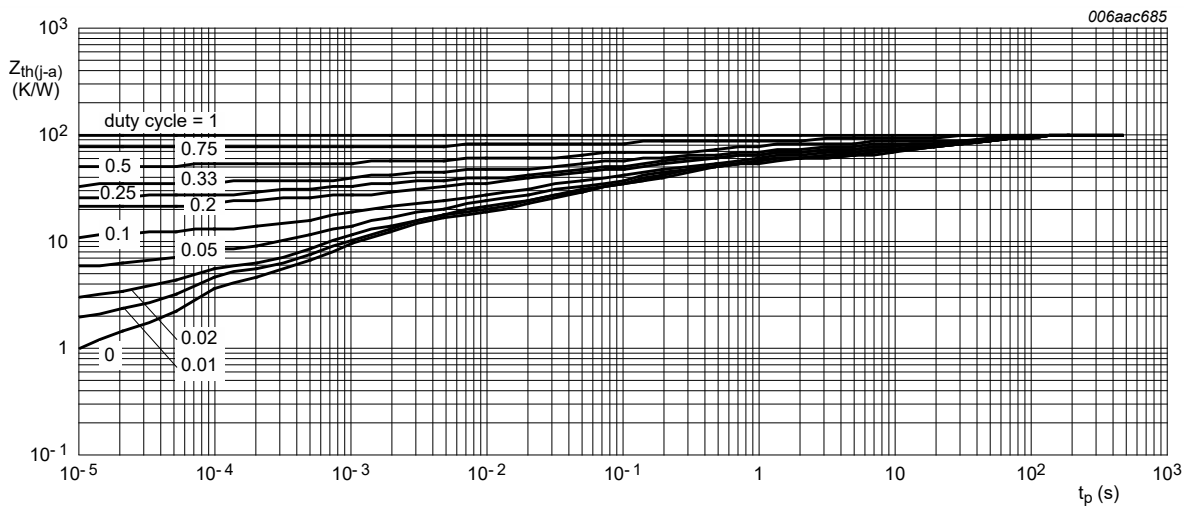


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values



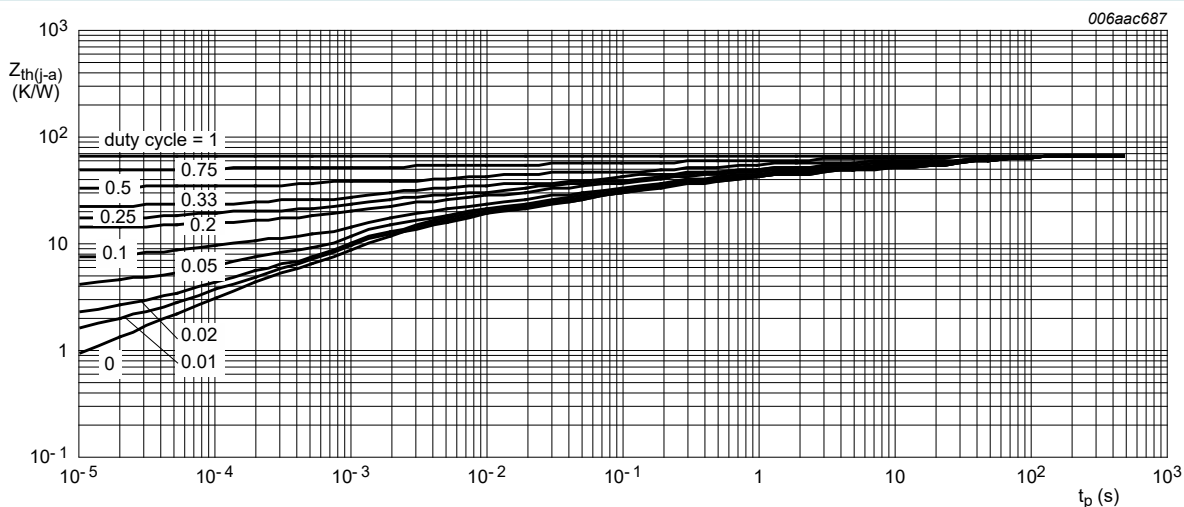
FR4 PCB, single-sided copper, mounting pad for collector 1 cm²

FR4 PCB, 4-layer copper, mounting pad for collector 1 cm²

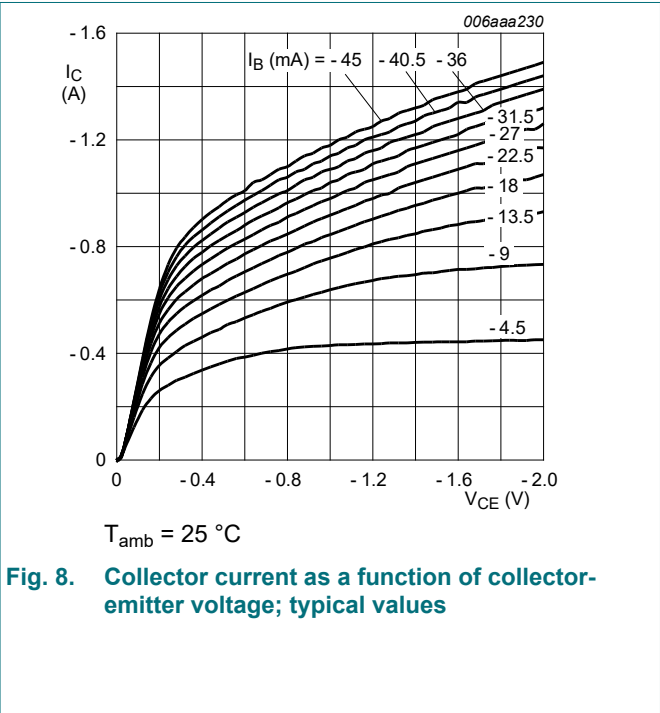
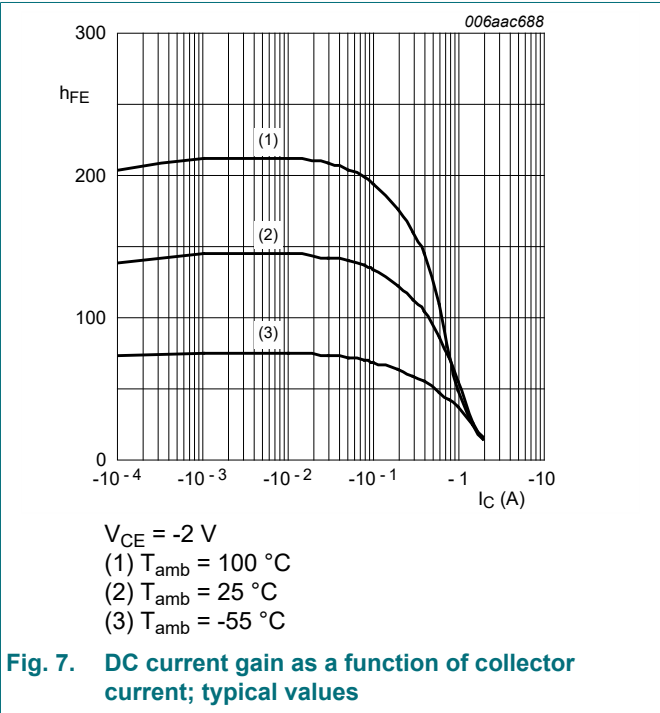
Fig. 6. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

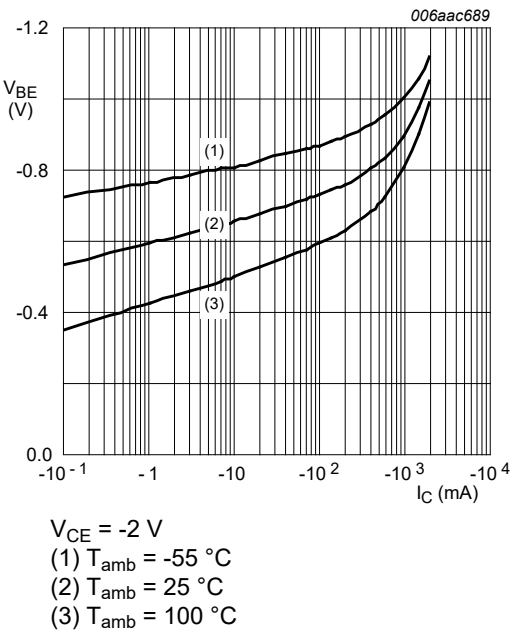


Fig. 9. Base-emitter voltage as a function of collector current; typical values

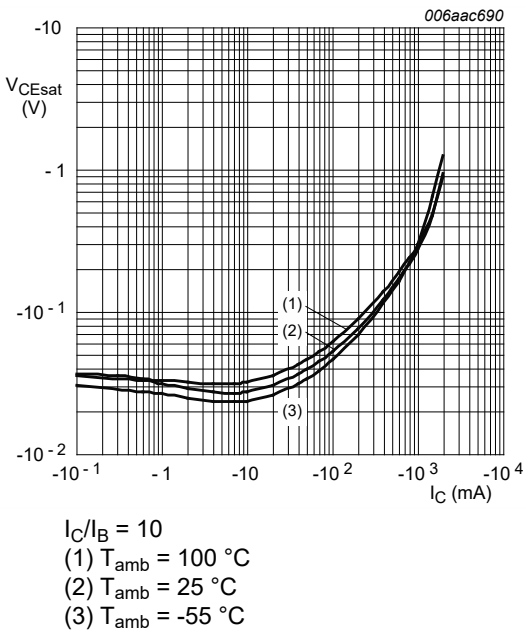


Fig. 10. Collector-emitter saturation voltage as a function of collector current; typical values

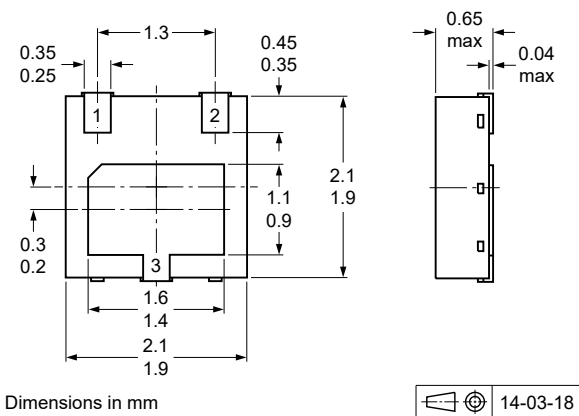


Fig. 11. Package outline DFN2020D-3 (SOT1061D)

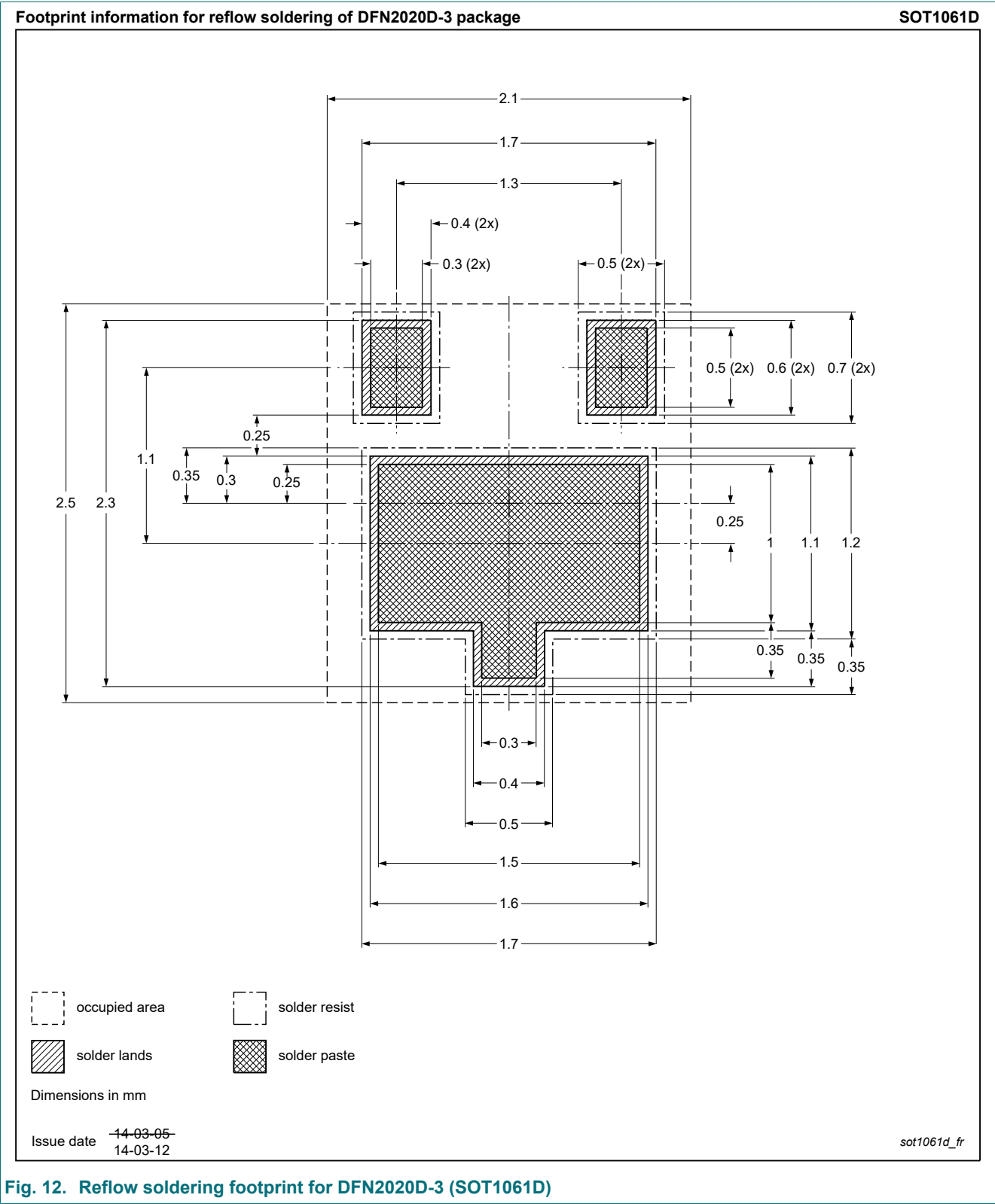


Fig. 12. Reflow soldering footprint for DFN2020D-3 (SOT1061D)
