LTCC (Low-Temperature Co-fired Ceramic) technology integrates multiple passive elements into a single monolithic structure, enabling slim, compact, and reliable microelectronic solutions.

The low-pass filter operates over a frequency range of 858–878 MHz and supports an operating temperature range of –40 °C to +85 °C, making it suitable for a wide variety of wireless communication applications.

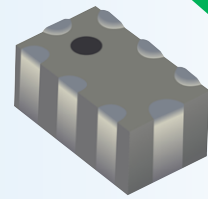

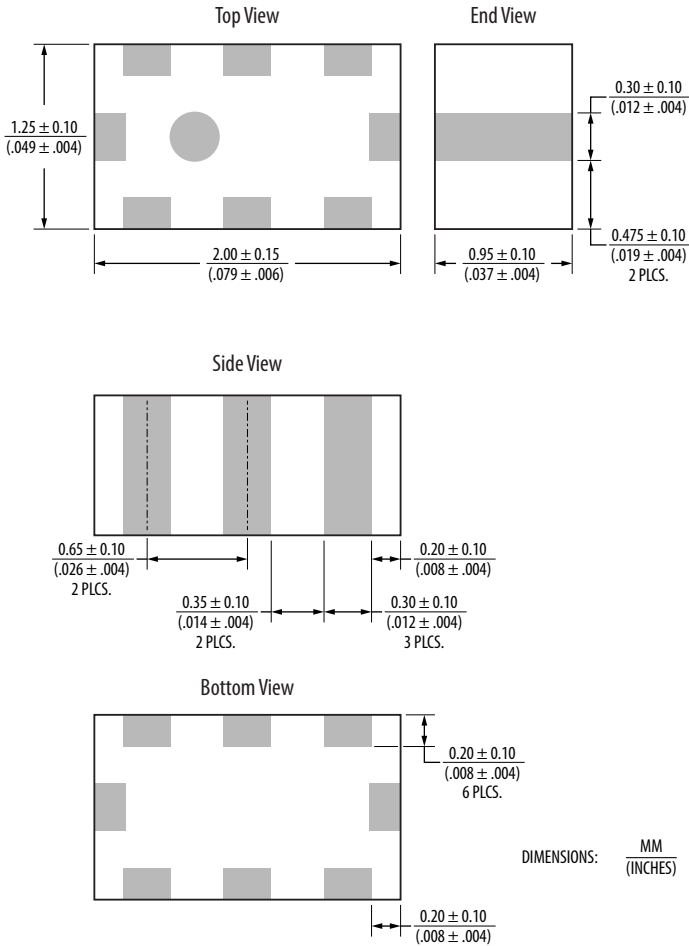

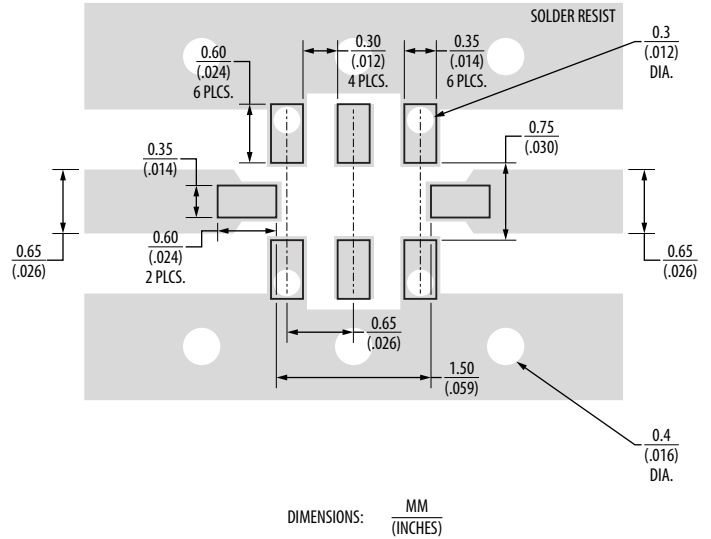

Product Dimensions



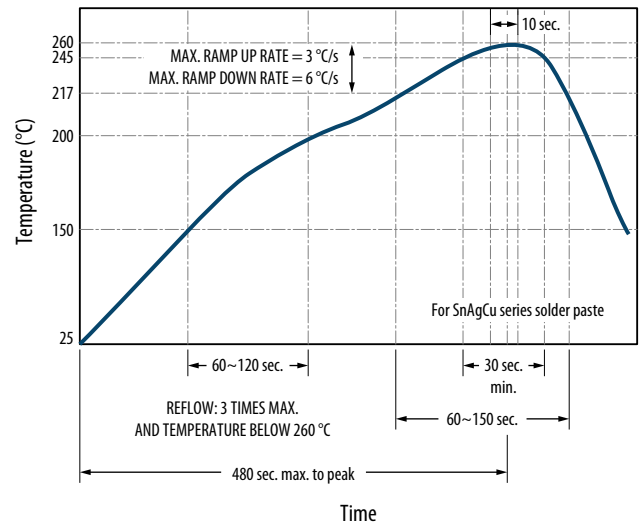
Recommended Land Pattern



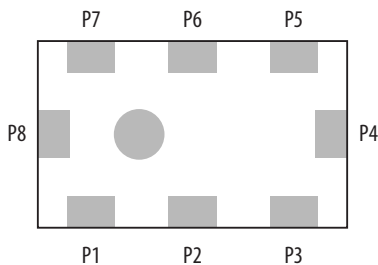

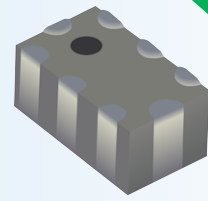
Soldering Profile



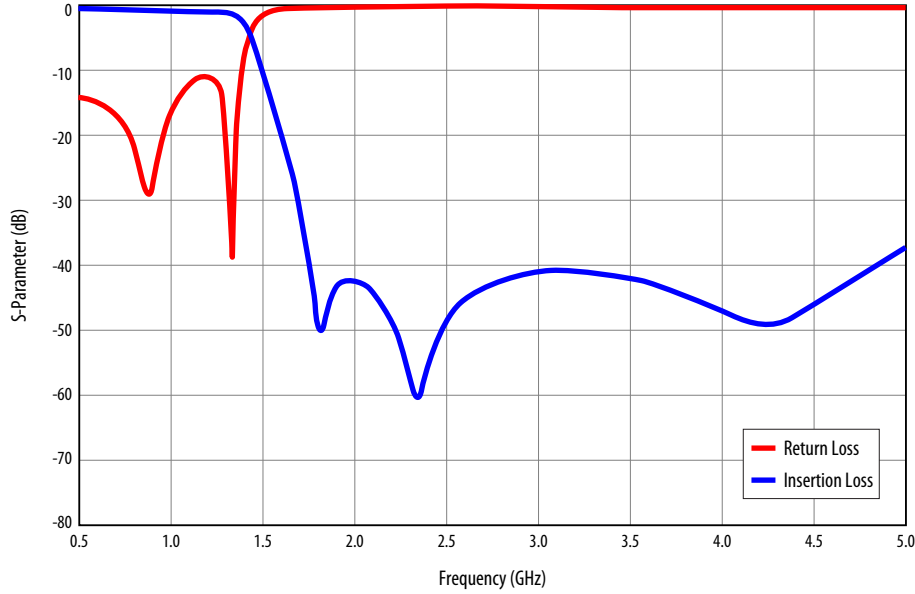

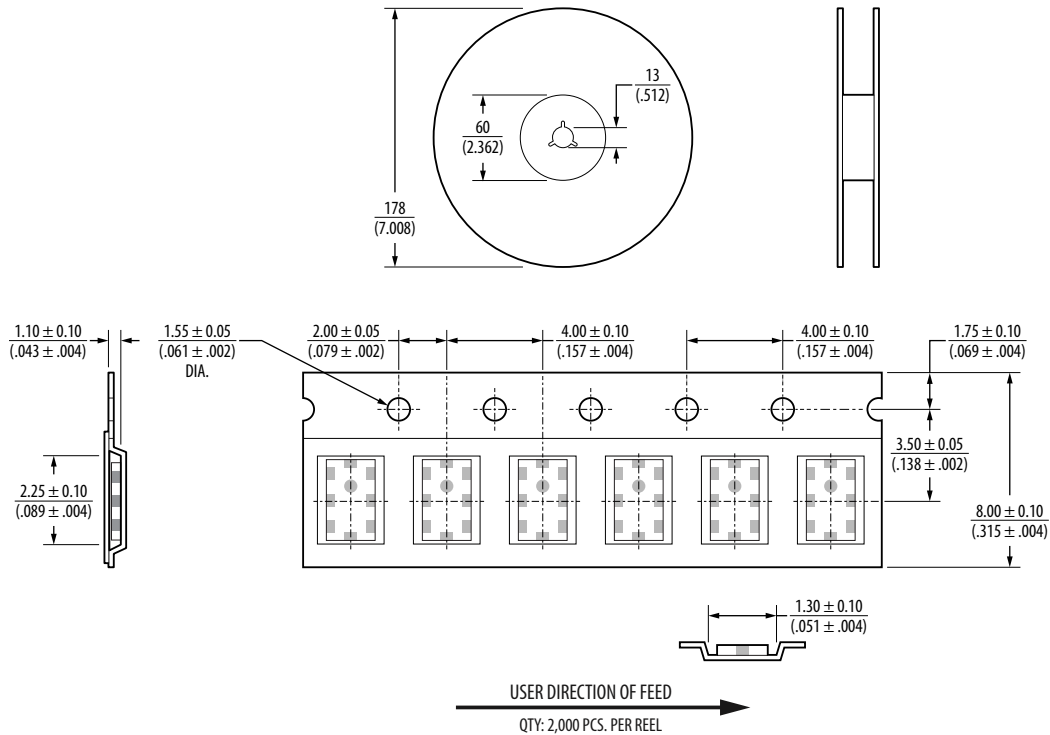
